The Renter acknowledges that they have received the tableware items in good condition. The Renter agrees to return the items in the same condition, normal wear and tear excepted.

Security Deposit:

The Renter shall provide a security deposit of **\$50 per 50 settings** to cover any damages, loss, or late return of the tableware items. The security deposit will be refunded to the Renter within **10** days after the items are returned in good condition.

SCCS will charge for all broken, damaged, or missing items, please count your orders before they are returned.

Pick-up:

We do not deliver any items. Pick-up arrangements must be made in advance. All rental items must to kept under cover until returned.

> All equipment is the responsibility of the Renter from the time of pick-up to the time of return.

Product Information:

All items are clean, and 'table ready". Please ensure that all items are clean and re-packed in the containers, boxes, etc.

- Lines: shake out and return in linen bags. **Please **DO NOT** launder and linens**
- > There is an extra charge for any burn holes or wax on linens.
- > There is a \$25 **minimum** cleaning charge on BBQ's returned dirty.

Late Return:

If the Renter fails to return the tableware items by the agreed-upon return date, a late fee of **\$10** per day will be charged until the items are returned.

Termination:

Either party may terminate this Agreement with written notice if the other party breaches any term or condition.
